Important Notice on Visa Restrictions and Entry Ban for Strengthening Border Security Measures to Prevent the Spread of Novel Coronavirus

On 28 August 2020, the Government of Japan decided to further strengthen the border security measures against the spread of Novel Coronavirus infections by introducing measures as follows;

1. Designation of areas subject to the entry ban

The following 13 countries have been newly added to the list below pursuant to the aforementioned decision. Foreign nationals who have stayed in these countries and regions within 14 days prior to the application for landing will be denied permission to enter Japan in principle. This measure is effective from 00:00am (JST) on August 30.

[Notes]

(1) Transit

Foreign nationals from the countries/regions where the entry bans do not apply are able to enter Japan without the "Letter of Confirmation of Submitting Required Documentation for Re-entry into Japan" and negative COVID 19 test result even when they arrive in Japan via the countries/regions which are subject to denial of permission to entry without entering these transit countries/regions if they can present the proof of the nature of such stopover such as boarding pass.

(2) Special Exceptional Circumstances (New entry cases)

Foreign nationals who are acknowledged to have special exceptional circumstances by Japanese authorities may enter Japan even if they have stayed in the aforementioned countries and regions within 14 days prior to the application for landing into Japan. Those foreign nationals are supposed to have a visa issued by Japanese overseas establishments with the date of issue later than the day when the country or region where they are currently staying was designated as an area subject to denial of permission to

enter Japan.

(3) Ongoing Phased Measures toward Resuming Cross-Border Travel for nationals of Thailand and Viet Nam

Nationals of Thailand and Viet Nam, who reside in their own countries and travel to Japan via direct flight from the respective countries need to have either a new visa (with "EX" in Remarks column) or the "Letter of Confirmation of Submitting Required Documentation for Re-entry into Japan" issued by Japanese overseas establishments in respective countries.

(4) Foreign nationals with status of residence (Re- entry cases)

The details of new measures for the re-entry of foreign nationals with status of residence will be notified later.

2. <u>Already-implemented measures on suspension of visa validity and suspension of visa exemption measures below will remain in place until further notice.</u>
